(FEDERAL DIRECT LOAN PROGRAM)

For UACCM to process your Parent PLUS Loan Request Form, you must complete the following steps:

- 1. The student must complete a Free Application for Federal Student Aid (FAFSA) for the current award year at www. studentaid.gov.
- 2. The student's current year financial aid file must be complete no holds or action items needed.
- 3. The parent must complete UACCM's Parent Plus Loan Request Form and return it to the UACCM Financial Aid Loan Analyst.
- 4. The parent must complete the Parent Direct Plus Loan Application ONLINE at www.studentaid.gov/plus-app. (Parent must have their own Federal Student Aid (FSA) ID and password)"
- Parent completion of the Direct Plus Loan Master Promissory Note and Direct Plus Loan Counseling at www.studentaid.gov
